A Noise Within (ANW) is dedicated to engaging adult and student audiences throughout Southern California with classic theatre while serving as a creative home for its ensemble of resident artists. Each season, ANW produces more than 180 performances across six classical works, reaching approximately 51,000 audience members, including 18,000 students and educators. ANW has earned numerous honors from theatre, arts, and business organizations in recognition of its artistic excellence, innovative leadership, and meaningful contributions to the cultural and civic vitality of Pasadena and the greater Los Angeles region. Reflecting this legacy, the Los Angeles Times has described ANW as "an oasis for those who love classic theatre."

4b (Code:) (Expenses \$ 1,238,909. including grants of \$) (Revenue \$ 178,152.) In a typical season, ANW's Education Program serves approximately 18,000 students and educators from nearly 200 schools across more than 40 school districts. The Education Program is made up of a carefully developed range of impactful theatre-based learning experiences, including:

a. Student Matinees & Evening Performances Weekday matinees for student audiences are performed by the same professional cast seen in evening productions. Each experience includes a pre-show orientation, a full-length performance, and a post-show conversation with the artists, facilitated by ANW's Director of Education. Based on need and availability, participating schools may

ANW's community-centered initiative, Noise Now, brings together readings, adaptations, multi-disciplinary performances, dance, visual art installations, and nontraditional theatre through partnerships with forward-thinking organizations across Los Angeles. These collaborations often focus on developing or presenting work that uplifts communities of color, including projects that reinterpret traditionally white or Western narratives through a BIPOC perspective, explore global mythologies, or highlight cultures that have been displaced or historically marginalized.
